What is going on with the lunches?

What do students at South Park High School have to say about the cafeteria lunches? An overwhelming majority of students surveyed said they think that the lunches are not healthy nor enjoyable.

A survey of students was taken, with 80 responses out of approximately 580 students. Only 8.8% said that they felt the lunches were healthy, 7.5% said they were enjoyable, and 66 students said they would change something about the lunches. Some students are not happy with the school’s lunch options.

Students’ main problem with the lunch menu is the excessive amount of chicken that is served. At least once a week some form of chicken is the main lunch option. Other students said they would add healthier options, more vegetarian options, fresher foods, more variety, better quality ingredients, a wider selection, and maybe even some special celebration days with take-out.

School lunches should be fuel for learning, not just filler. The federal register from The Department of Agriculture says that each student should have an item from every food group on their tray at lunch time, with ample milk, fruit, and vegetable options. (see photo) Right now, if you go into the cafeteria, you will see pizza, chicken, burgers, and chocolate chip cookies. The food is not only not healthy, but sometime unappetizing.

Schools around the country are struggling with getting high-quality lunches. Bulk food orders are difficult to fulfill right now, as there is no place with enough food to have variety, but President Joe Biden has introduced a solution to this shortage. *AP News* says, “The Biden administration issued transitional standards for school lunches Friday that are meant to ease the path for cafeterias to get back on a more healthful course as they recover from pandemic and supply chain disruptions.” This new solution could make lunches healthier, more accessible, and even more enjoyable.

Black History Month

Malcolm X

Black History Month was created to focus attention on African Americans coming to the United States. This month recognizes all African Americans for their accomplishments and how far they have come since slavery, which goes back to 1619.

Malcolm Little, better known as, “Malcolm X” was an African American leader in the civil rights movement, minister, and supporter of Black nationalism. He urged his fellow Black Americans to protect themselves against white aggression “by any means necessary,” which became a stance that often put him at odds with the nonviolent teachings of Martin Luther King, Jr. In March 1964, Malcolm X announced he was leaving the movement and a month later he gave his infamous "The Ballot or the Bullet" speech at a Baptist church in Detroit, Michigan, stressing the need for African-Americans to pursue Black Nationalism and arguing against the non-violent protest.

At age 39 Malcolm died on February 21, 1965, when he was assassinated in New York City. Three Nation members were charged with the murder and given indeterminate life sentences, in 2021 two of the convictions were vacated. Malcolm X made a huge impact on history and helped thousands of African Americans stand up for what they believed in. He may not still be here today, but many people still know and love him so much.



Rosa Parks

Rosa Parks was not the first African American woman to be arrested for refusing to yield her seat on the Montgomery bus. She refused on principle to surrender her seat because of her race, which required by the law in Montgomery at the time. Parks was a civil rights activist before her arrest, parks became involved in the Civil Rights Movement as early as December 1943. Rosa Parks is most famous for refusing to obey orders from a bus driver when he told her to surrender her seat in the “colored section. Rosa Parks was born February 4, 1913 and was an American Civil Rights Activist best known for her role in the Montgomery Bus Boycott. The United States congress has honored her as “The First Lady of Civil Rights” and “The Mother of the Freedom Movement.”

Martin Luther King Jr.

Martin Luther King Jr is known as one of America's greatest heroes. In the 1950s and 1960s, he fought to end laws that were unfair to African Americans. He worked to make sure all Americans had equal rights. From 1957 to 1968, King traveled over 6million miles and spoke over 2,500 times and he was imprisoned nearly 30 times. King was largely responsible for the passage of the Civil Rights Act of 1964 and the voting rights act of 1965. The Civil Rights Act banned discrimination in the workplace and public accommodations based on “race, color, religion, or national origin.” The Voting Rights Act protects African Americans rights to vote. King sought equality and human rights for African Americans, the economically disadvantaged and all victims of injustice through peaceful protest.

Harriet Tubman

Harriet Tubman was born a slave and raised on Maryland’s Eastern Shore where the lines between slavery and freedom were often blurred. It was not unusual for families in this area to include both free and enslaved members. Tubman escaped and subsequently made some 13 missions to rescue approximately 70 enslaved people, including family and friends, using the network of antislavery activists and safe houses known as the Underground Railroad. She also was Union spy and the first Black woman to ever lead on American mission during the American Civil War. Harriet Tubman was one of the most courageous and determined freedom fighters in U.S. history. She rose from a childhood of brutal abuse by slaveholders to emancipate herself, and she risked her life repeatedly to liberate others. She assisted many others with her knowledge of safe spaces and escape routes. “I never ran my train off the track and I never lost a passenger,” she later said of her experience. In years conducting the Underground Railroad she had made 19 trips and guided her parents, siblings, relatives, and friends for a total of around 300 enslaved people.

Facebook or Meta?

Facebook has been recently going through a lawsuit with The Federal Trade Commission (FTC) for allegedly abusing their powers. According to The New York Times, Facebook has spread misinformation, conspiracies, and hate speech throughout their platform.

Facebook has decided to completely rebrand themselves and their platform as Meta Platforms. After the lawsuit, Facebook wanted to reinvent their name to distance themselves from the negative connotation around their platforms and brands and to show that their brand isn't tightly linked to one certain product, yet the whole platform. Facebook, and its other apps, Instagram, Whatsapp, and Messenger will be housed in a separate division from Facebook Reality Labs, which makes the companies virtual reality products.

The FTC lawsuit was brought about after internal documents were leaked by a former product manager, Frances Haugen. The documents were provided to Congress, and a censored version was obtained by news organizations. They revealed a rare insight into the company that included making decisions that seem to prioritize profits over the well-being of its users.

Facebook doesn't have a perfect platform, like many others. Do platforms have the right to prioritize profits over the well-being of their own users or not take down false information? Is Facebook in the wrong?

Sharks aren't as dangerous as you might think

Did you know that about 100 million sharks are killed per year? According to greenpeace.org destructive fishing methods are used in major fishing countries and are resulting in the death of sharks worldwide.

Scubadiving.com stated facts about the movie "Jaws" and how it invokes fear surrounding sharks. However, a professor at the University of South Australia, Brianna Le Busque became curious if other shark movies have the same effect. Le Busque states "The media has a really big impact when it comes to how people view sharks...There are a few studies that have looked at 'Jaws' specifically but there was no research looking at shark films more generally." In all, about 105 shark movies out of the 109 movies Brianna has taken a look at are leaning more towards the fact that sharks are dangerous and potentially harmful to people.

Sharks are portrayed so negatively. However, according to people.com there are "73 unprovoked shark attacks recorded in 2021." Shark attacks aren't extremely common, but people are more scared of sharks than they are car crashes. Six million car crashes happen per year and over 90 people die in car crashes per day, but there are only 72-73 shark attacks and they are rarely fatal. More people are scared of something less dangerous.

We need to protect and save sharks rather than kill them or be scared of them. Sharks are an important part of the oceans and ecosystems.

Tinder: Victims strike back

As everyone knows, most high schoolers don't have to worry about their use of the popular dating app, Tinder. However, there are legally adult seniors on Tinder with no clue how dangerous it could really be.

There is a documentary called "The Tinder Swindler" on Netflix. This documentary shares the perspectives of three women who fell victim to a manipulative con-artist that they met on the dating app. These three women each shared their personal experiences with a man they thought to be named Simon Leviev, the CEO of LLD Diamonds, and sitting on millions of riches. In reality, Shimon Hayut was a scam artist who had already been reported for these crimes to news companies, but the police had yet to catch him.

The breakdown: Simon had a Tinder profile decorated with pictures of fancy cars, restaurants, and expensive trips. He was also a good-looking man. The first woman in the documentary, Cecilie Fjellhøy, had been wooed by Simon on the first date. He met her at a 5-star hotel, and afterwards invited her to travel to Bulgaria on his private jet, to which she agreed. Once she got back, the two had entered a relationship. After sweet talk and spoils, it came time for Simon to begin his scam. First, he would send pictures of his bodyguard injured and say that he had been attacked by his "enemies" who were trying to kill him and take his company. Next, he'd mention that he was on the run, constantly flying to other countries. He explained that he was unable to use his cards in his name because they could be traced by his "enemies," and that he had to use the cards in the woman's name, through the woman's account. This is when he started asking for funding in cash or in large amounts on the card. He asked Cecilie for \$25,000 cash, and Pernilla for \$30,000 cash, as well as making these women take out several loans at a time to provide what they thought was safety for their significant other. He would pay them back after the first few times, but after that he would continue to demand more money every few days.

Once these women figured out the dangers of this man, he would threaten them if they spoke to anyone that they would be making a grave mistake. However, the last woman interviewed, Ayleen Charlotte, had noticed what the con-artist was doing. She began to sell the expensive name-brand Gucci clothing online and kept the revenue for herself. He got suspicious after she wouldn't give him the money she earned and began to get angry.

This man was not only a con-man, but he was a manipulative narcissist as well. If the woman didn't comply with his requests he immediately attempted to make them feel bad for him, or if they found out his act he would threaten them.




